above for fire fighting, prevention and protection contractor for carrying out Supply and Installation of Automatic Sprinkler System for GEPF House on Plot No.37, Ali Hassan Mwinyi Road, Regent Estate-Dsm.

4. Tendering will be conducted through the **National Competitive Tendering** procedures, specified in the Public Procurement Regulations, 2013 – Government Notice No. 446 and is open to Bidder as defined in the Regulations.
